

## SYDNEY OPEN GIVEAWAY TERMS AND CONDITIONS

1. Participation in South Eveleigh Social Media Competition ("**Promotion**") is deemed acceptance of these Terms and Conditions. All times and dates throughout these Terms and Conditions are based on Australian Eastern Standard Time (AEST) or Australian Eastern Daylight Savings Time (AEDST) as the case requires. The "Participating Centre" is South Eveleigh
